Guide to the conference venue

The venue for this year's ATCR is the International Labour Organization (ILO) building. The International Labour Organization is devoted to advancing opportunities for women and men to obtain decent and productive employment in free, equitable, secure and dignified conditions. The main aims of the ILO are to promote rights at work, encourage decent employment opportunities, enhance social protection and strengthen dialogue in handling work-related issues. The ILO became the first specialized agency of the UN in 1946.

Registration Instructions

When you enter the building please follow the ATCR-signs, up the stairs to your right to the plenary room (Salle II). Registration will take place between 8:00 AM and 9:00 AM on Tuesday, 6 July 2010 in the front of the plenary room. You will there receive your conference pass which provides full access to the meeting.

ILO- Security Card

At the registration desk you will receive an ILO-security pass and an ATCR-conference pass. This ILO security pass is a magnetic badge and provides full access to the ILO building. Please do not leave the building without collecting your security pass as you will not be able to re-enter the build-

ing the next day. The security pass will be valid for the duration of the ATCR, 6-8 July 2010.

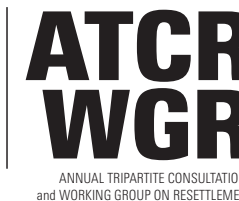
Please note that the ILO-security pass must be returned directly to UNHCR on the final day of the conference. A cost will be incurred by participants for the loss of the pass.

Coffee Breaks and Lunches

Lunches and some coffee breaks are not provided by the Chair, but at the ILO you can find a Eurest restaurant on the ground floor when you enter the building. During lunches it's there are typically long waiting lines, and in order to avoid long queues we instead recommend the smaller Eurest cafeteria at second floor (the same floor as the plenary room).

Coffee and tea that will be provided (please see agenda for more information) will be served in the Expo area on the second floor close to the plenary room or in the open space in the middle of the building on the first floor.



Session formats

The ATCR of 2010 aims at bringing participants from States, NGOs and UNHCR together into collaborative and productive sessions of information sharing and development of ideas and recommendations for the future. The meeting invites 200 participants from States, NGOs and IGOs and the agenda has been designed with consideration to the size and delivery of content. The meeting will be held in the following settings:

Plenary sessions:

involve presentations and/or an interactive setting where the participants are able to ask questions to the speakers. The concept 'Conversation Café' (a moderated dialogue with interaction from the audience) which was introduced at the Working Group in March will be used on some occasions when reflection and dialogue is preferred over pre-made statements.

Break-out sessions::

During day one and two, the presentations in plenary will be complemented by break out sessions. The purpose of these sessions is to facilitate information sharing and Q & A in a smaller setting than can be accomplished in the plenary room.

Participants workshop sessions:

During the afternoon of day two, plenary sessions will be combined with three workshops, which will enable participants to engage in discussions on the ATCR review. The workshops are more interactive than the break-out sessions and depend on active participation from those attending.

Resettlement Expo:

This year's ATCR introduces a Resettlement Expo. The Expo is set up outside and around the entrance to the plenary meeting room, and will provide participants with a combination of information and inspiration. Among other items, this year's Tour de Table will be displayed in the Expo for participants to access during coffee breaks and lunches.
